12. Public Health:

The flu is high throughout the state currently. The B strain is most common and having an adverse reaction to kids. Typically the flu is not this high until later in the season but it is rising earlier this year. The ruling on the elimination of religious exemptions for vaccinations vote is coming up. There was a salmonella outbreak reported related to NJ produce. Trends on vaping are more than underage drinking and smoking although Ramsey Alliance has not seen that.

13. Vital Statistics:

There were 3 marriages in Ramsey. There were 7 deaths of Ramsey residents; 3 male and 4 female. There were 3 deaths that occurred in Ramsey; 1 male and 2 female. This month 3 marriage licenses were issued, 12 marriage certified copies were issued, and 230 certified death certificates were issued.
