### **ENGINEER'S REPORT**

Mr. Bacolo thanked the Board for re-appointment as the Boards' consulting engineer. He provided an update on lead service line inventory and replacement project, phase 1B, and Crew is continuing with the preparation of the bid documents. Planning to replace approx. a minimum of 20 services in 2023 to meet the NJ requirement of 10% replacement. There are 19 services left for replacement, the locations have been mapped out by Crew. The bid documents will be advertised in February with the bid opening to be in March. The county notified Ramsey that Wyckoff Ave will be paved in the Spring. As such, the services on Wyckoff Ave will need to be deferred until the end of the county moratorium which is five years.

The Decommission of test wells has been completed.

N. Central original pump house has some cracks in the interior walls. Crew is working on final report of investigation on their findings. Initial report showed there was some settling in the soil leading to the cracks in wall.

Crew Engineers is merging with H2M Architects + Engineers at the end of January. Crew will maintain its Butler offices.

#### **OPERATIONS REPORT**

Mr. Skorupa reported that the water dept continues with their daily duties. They repaired a water main break on Sherwood Drive. Mr. Skorupa thanked the Board members, Crew, Mr. DeBlock and Board Attorney Mr. Corriston for continuing to serve on the Board.

<u>OPERATIONS MANAGEMENT REPORT</u> – Mr. DeBlock thanked the Board for his reappointment. The water conservation plan was prepared by Crew and has been completed. Planning to meet with Crew, Mr. Skorupa and the Mayor to review the water accountability act.

<u>ATTORNEY'S REPORT</u> Mr. Corriston has two items for closed session involving contracts. The draft ordinance has been forwarded to the Mayor & Council and Borough Attorney Mr. Scandariato for review. Thank you to the Board for appointing his office as Board Attorney.

<u>MAYOR'S REPORT</u> Thank you to everyone for serving once again on the Board of Public Works. Congratulations to Dr. Boff for joining the Board.

<u>ADMINISTRATOR'S REPORT</u> Mr. Vozeh is working on the budget for 2023. The draft budget should be ready for review at our February meeting.
