APPLICATIONS

PC Harwood Floors Mr. Freidman was present. He is planning to add one façade signs and two awnings to the PC Harwood Floors building. They will be black and yellow. The following was approved by the Design Review Board (per Planning Board REVSIED approval) for 2 awnings and 1 façade sign, with following specifications: size: #1 façade 16' X 28" / material: aluminum / Colors: Black & Yellow. No illumination. size: #2 awning 4' X 6"/ material: fabric/ Colors: Black & Yellow. No illumination. size: #3 awning 80" / material: fabric / Colors: Black & Yellow. No illumination.

Mr. Friedman was advised that on window coverage, no more than 20 percent of available space can be used for display or advertising purposes.

Leslie Pools: Mr. Fox was present. He is planning to add one façade sign. The following was approved by the Design Review Board (per Planning Board approval) for 1 façade sign, with following specifications: size: façade 16 – 2 9/16' X 29" = 39.18 sq. ft. / material: acrylic / Colors: Red, White & Blue. White Channel LED illumination.

Board Discussion and Questions: Mr. Verdone asked what hours the sign will be illuminated. Mr. Fox responded it will be for the hours that Interstate is open.

RJP Plumbing: Mr. Piliaskas was present. He is planning to install a black and red sign using the existing sign frame. The following was approved by the Design Review Board (per Planning Board approval) for a facade sign, with following specifications: 4' X 8', size: 32 sq. ft. / material: aluminum/ Colors: Black & Red/ White. No illumination.
