AND BE IT FURTHER RESOLVED that the Borough Clerk be and she hereby is, directed to cause a copy of the title of said ordinance to be published in an official newspaper of the Borough in the manner provided by law together with notice of the date of introduction and adoption of said ordinance.

Councilwoman Jachzel explained that this ordinance allows the borough to bank for two years certain unused appropriations that may be applied in future budget giving the borough flexibility with the 2% appropriations cap on certain budgetary items such as operations.

Councilman Verdone explained that this ordinance establishes a new section which regulates the location and operation of retailers of all such products listed in the ordinance with the objective to maintain the borough's character and quality of life.
