- 2. The roll was called by Mrs. Sobanko. In attendance were Mrs. Waring, Mr. Lara, Ms. Martin, Ms. Poppe, Mr. Yanovich and Mrs. Sobanko .The minutes from Feb.8th, 2018 were approved. Motion was made by Ms. Martin, second by Mr. Lara.
- 3. Announcements: Our next lecture is on mental illness .Sophia Hefler, a Ramsey resident, is the speaker. "In our own voice" tells of her experiences with deep depression, suicide attempts and multiple mental illnesses. Mrs. Waring stated that she still struggles but yet has it together. Her choice was to endure the stigma or die. She has also spoken at the high school.

Ramsey Schools have been recognized for their work on being stigma free.

There will be a walk a thon at the high school on May 1st to stimulate conversation with family and neighbors. May is Mental Health Month.

4 Codes. Ordinances & Legislation: There is talk about restricting religious exemptions in the schools. Parents may now have to apply for it and bring a notarized written statement on how the vaccination violates their religious practices. They may also have to sign a statement that they understand the benefits and risks of vaccinations and a signed statement from a New Jersey physician that they have explained this to the patients/families.

A special flu vaccine may be coming out for people over 50 or 55.

There is talk of the state being sued to allow home baked goods at charitable events.

5 Special Matters: Ms. Poppe reported that the Drug Alliance will have a table for drug take back set up at the walk a thon on May 1st. The Ramsey Police will bring a box. They are also trying to spread the word about the 411. This can be used to report things such as a loose dog, a loud party or any suspicious behavior. It can be an anonymous call. It is not the same as 911! They are also trying to get the word out about Nixel, texts to alert you about snow, road closures etc. The alliance will also have a drug box at the farmers market on June 10th, with a "meet the police". Ms. Poppe also reached out to Mr. Yanovich to see if they can have a speakers come in on vaping, drugs or cigarettes. She attended a lecture by Lacey Benjamin on vaping given by the Mahwah Alliance. Could there be such a program at the library after school? Mr. Yanovich will check with HARP. In Mahwah if someone is caught smoking on school property there is a \$250.00 fine. They also are bringing underage kids to see if vaping or tobacco products are being sold to buyers under the age of 21. Ramsey may choose to do this also or at least guiz the owners to see if they are aware of the age requirements. Mrs. Sobanko will check when she does inspections.

Martha had been called to a townhouse that contained a toxic substance. It was deemed to be cleaned by an outside company. We are tracking and following up on expired food licenses. Summons has been issued. Anthony Franco's was conditional. It is now satisfactory.
