REGULAR MEETING

APPLICATIONS

Lincoln Dealership – 66 Rt. 17 North. Mr. Marty Yarbrough of Hub Signs submitted an application for three façade signs and a pylon sign. The following was approved by the Design Review Board with the following specifications:

Façade (SERVICE): 7’2^{1/2}” X 1’9^{5/16}”
Material: aluminum
Colors: grey & silver
Illumination: yes

Façade (LINCOLN) 26’ – 11^{3/8} X 2’11” ^{3/4}
Material: aluminum
Colors: silver
Illumination: yes

Façade (RAMSEY) 5’ 2 ¼” X 12”
Material: aluminum
Colors: silver
Illumination: yes

Façade (STAR Wall Logo) 5’3” X 12’ 1”
Material: aluminum
Colors: brown & silver
Illumination: yes

Pylon (LINCOLN)
Material: aluminum cabinet & acrylic logo
Colors: brown & silver
Illumination: yes

Mr. Yarbrough was advised that on window coverage, no more than 20 percent of available space can be used for display or advertising purposes.

Burlington – 235 Interstate Shopping Center – Mr. Scott Bilbrey of Blair sing program submitted an application for replacement façade and pylon signs. The following was **not** approved by the Design Review Board with the following specifications:

Colors: red & white
Illumination: no

Pylon #2: 27^{1/2}” X 168”

Materials: plastic
Colors: red and white
Illumination: no
