2. The roll was called by Mrs. Wiegand. In attendance were Mrs. Waring, Mr. Nemeth, Mr. Lara, Ms. Poppe, Dr. Tartini, Mrs. Kane, Mrs. Azouri, Mr. Yanovich, Councilman Gutwetter and Mrs. Wiegand. The minutes from June 14th, 2018 were approved. Motion was made by Mrs. Kane, seconded by Mr. Nemeth and carried by all.
3. **Announcements:** .CHIP has mentioned the possibility of a tai chi class at Darlington Park from 5-6:30 on Tuesdays in Sept. and Oct. Mrs. Waring wanted comment from the Board. Do we think anyone would go? A Saturday am class might get a bigger turnout. Some senior's might not attend an evening class.
4. **Codes. Ordinances & Legislation:** The Bill to tighten the religious exemptions for childhood vaccines is still not finalized.
5. **Drug Alliance/Special Matters:** Ms. Poppe announced that there will be Mental Health First Aid classes on August 20 and 21. The classes will run from 6-10. You must attend both sessions. There will also be one session on Wednesday August 22 that will be held from 8:30-4:30. Both will be at Ramsey High School. A charge of \$10.00 for emergency services, \$15 for Ramsey Residents and \$20 for non-Residents will be collected. The classes are limited to 30 participants. Ms. Poppe is also attending an anti bullying symposium at Met Life with Gregory Acocella, Director of Special Services for Ramsey schools. A "Hidden in Plain Sight" program will take place in October.

Dr. Tartini advised that there is such a demand for the new Shingles vaccine that it may need to be ordered 6 months in advance. Deer related accidents are rising and there are higher numbers of insurance claims.
