

**RAMSEY POOL COMMISSION**  
**MINUTES OF A REGULAR MEETING, WEDNESDAY, AUGUST 19, 2020**

The monthly meeting of the Pool Commission was called to order on Wednesday, August 19, 2020 at 8:00 p.m. by Mrs. Hewitt. Also present were Mrs. Hoffman, Mr. Jost, Mrs. Maurer, Mrs. Meyer, Mrs. Suarez, Commission members, Mr. Bach, Pool Manager, and Mrs. Dey, Secretary. Council Liaison Jones was absent.

In accordance with the laws of the State of New Jersey, public notice of the meeting was published in The Record and The Ridgewood News, and posted in the Municipal Building.

Upon motion by Mrs. Hewitt, seconded by Mr. Jost, the minutes of the July 15, 2020 meeting were approved as received.

**REPORT OF THE POOL MANAGER (AGENDA ITEMS)**

The numbers for 2019 and 2020 were shared. Currently, family memberships total 1,542 in comparison to 2,414 in 2019, out-of-town memberships-252 (2020)/443 (2019), senior memberships-313/385, individual memberships-45/46, and swim team members-110/136. The total revenue for 2020 is currently \$317,000+ compared to \$525,000+ in 2019. An August membership fee structure was developed and accounts for sixty-seven family memberships, nine out-of-town memberships, eleven senior memberships, and one individual membership out of the previously noted seasonal memberships.

The last day of the 2020 season is Friday, September 11<sup>th</sup>. Weekday pool hours starting on Thursday, September 3<sup>rd</sup> are 4 to 7 p.m. There will be regular hours for Labor Day weekend.

Mr. Bach reviewed the 2020 pool expenses with Denise Bartalotta, Borough CFO, and Borough Administrator Vozech. Reimbursement of up to seventy-five percent is available from FEMA for coronavirus-related expenses.
