REPORT OF THE POOL MANAGER (AGENDA ITEMS)

Going back to 2018, the membership numbers are as follows, as of March 14th: Family memberships-\$29,000 (250 members) (2018), \$30,000 (240) (2019), \$72,000 (550) (2021), \$88,000 (565) (2022), \$74,175 (419) (2023); Out-of-Town memberships-\$7,000 (30) (2018), \$11,000 (50) (2019), \$22,000 (78) (2021), \$41,200 (140) (2022), \$36,000 (110) (2023); Senior memberships-\$1,600 (32) (2018), \$2,000 (30) (2019), \$4,700 (90) (2021), \$7,500 (111) (2022), \$6,000 (86) (2023). The total thus far for 2023 is \$115,000. Registration started a week later in 2023.
