**SPECIAL MEETING of SEPTEMBER 26, 2022**  
**Via in person & Conference call**

Mr. Coronato called the special meeting of The Board of Public Works to order at 9:01 am. The meeting was conducted in-person and by conference call.

Mr. Coronato announced that the meeting is being held in accordance with the Sunshine Laws of the State of New Jersey. Public Notice of this special meeting was published in The Bergen Record on September 25<sup>th</sup>, 2022.

Board members present (in person & via conference call) were; Mayor Dillon, Mr. Coronato, Mr. Emmett, Dr. Goujani, Mr. Tyburczy and Mr. Emmer. Along with Mr. Vozeh, Mr. Bacolo, Mr. Corriston, Councilwoman Cusick and Mrs. Sylvester. Mr. Hewitt, Mr. Skorupa and Mr. DeBlock were absent.

Mr. Vozeh noted the special meeting is to correct the bid amount from William Stothoff Company for the decommissioning of test wells. At the Board meeting on Sept. 19<sup>th</sup>, 2022 the incorrect amount of \$65,245 was verbalized in the resolution. The correct amount of the bid is \$68,900.

The second item for this special meeting is the approval of a four-year contract for the Teamsters Union Local #11 which is the water and sewer employees under Mr. Skorupa. An agreement had been reached. Mr. Vozeh recommends approval from the Board of this new contract.

Motion by Mr. Coronato approving the bid award amount to William Stothoff Company to the correct submitted bid amount of \$68,900 for the decommissioning of test wells. Seconded by Mr. Tyburczy. Carried.
